To respond to user inquiries or to address requests submitted through the website.	Processing is based on the Data Controller's legitimate interest in promptly responding to user requests and providing relevant information.	For this purpose, users are free not to provide their personal data; however, in such cases, the Controller will not be able to respond to their requests.

## 3 data recipients

A complete list of data recipients is available upon request. Personal data will not be publicly disclosed.


#### 4 data transfer outside the EU

Data will not be transferred outside the European Union. If such transfer becomes necessary, it will be carried out in compliance with applicable legal safeguards, such as Standard Contractual Clauses approved by the European Commission or equivalent measures. #### 5 data retention

Personal data will be retained for no longer than necessary to achieve the purposes for which they were collected. Specifically, data provided to access the website will be retained only for the duration of the session or service. Newsletter subscription data will be retained until the user withdraws consent. Once these periods expire, the data will be securely deleted or anonymized in a way that prevents any identification, even indirect.

## 6 profiling

Users' data will not be used for profiling or for making decisions solely based on automated processing. For cookie-based profiling, please refer to the Cookie Policy.

## 7 user rights

You have the following rights:

- right of access to data: the right to obtain confirmation from the Data
  Controller as to whether or not personal data concerning you are being
  processed, and if so, to access such data including receiving a copy –
  and to obtain information regarding the processing;
- right of rectification of data: the right to obtain from the Data Controller, without undue delay, the correction of inaccurate personal data concerning you and the completion of incomplete data, including by providing a supplementary statement;
- right to erasure of data ("right to be forgotten"): the right to obtain from the Data Controller the deletion of personal data concerning you without undue delay where one of the following grounds applies:
  - the personal data are no longer necessary for the purposes for which they were collected or otherwise processed;
  - you object to the processing and there are no overriding legitimate grounds to continue;
  - o the personal data have been unlawfully processed;
  - the personal data must be erased to comply with a legal obligation to which the Controller is subject;
- right to restriction of processing: the right to obtain restriction of processing from the Data Controller where one of the following applies:
  - you contest the accuracy of the personal data, for the time necessary for the Controller to verify their accuracy;
  - the processing is unlawful, and you oppose the erasure of the data, requesting instead the restriction of their use;
  - although the Controller no longer needs the data for processing purposes, they are required by you for the establishment, exercise, or defense of legal claims;
  - you have objected to processing pending verification of whether the Controller's legitimate grounds override yours;
- right to data portability: the right to receive your personal data, which
  you provided to the Controller, in a structured, commonly used and
  machine-readable format, and to transmit those data to another
  controller where processing is based on consent or a contract and
  carried out by automated means;
- right to object: the right to object to processing carried out in the public interest or in the exercise of official authority, or based on the legitimate interest of the Controller or third parties. This includes the right to
